Investigator Newman received his bachelor's degree from Old Dominion University in 1986 in Criminal Justice and has lectured several hundred hours to law enforcement agencies at all levels across the country on the topic of homicide investigation and its related forensic applications. His courses have been taught in conjunction with the Virginia State Division of Forensic Science and the Office of the Chief Medical Examiner. Investigator Newman has also instructed basic and advanced forensics at Thomas Nelson College in Virginia, equivocal death scenes at the Virginia State Division of Forensic Science and is a qualified expert in death investigation and its related forensic fields. His expertise in crime scene management through development of standard operating procedures have been adopted by several agencies across the country with great success. Inv. David Newman continues to provide aid in cold cases, 911 analysis and expert courtroom testimony resulting in over 30 years of experience.
